Town Manager Report

- ADEQ is requesting an update for the Consent Order regarding the TTHm issue.
 - During that discussion ADEQ stated the additional clarifier would not be approved. Further investigation determined the clarifier is necessary for the continued improvement and maintenance of the Water Plant; and would ultimately aid in the meeting the thresholds.
 - ADEQ is also recommending a booster pump at Avenue 28E on the new 8" water line.

- San Francisco Avenue Road Improvements bids came in much higher than the budget.
 The scope of work has been reduced. Staff is waiting for the approval from ADOH on the reduced scope.
- The new officer is scheduled to graduate from the Academy in February. Field Training will be roughly 3 months.
- Broadband Update: The Board of Supervisors voted 3-2 to award the RFP to Allo.
- RAGHT (Rural Arizona Group Health Trust) Annual Conference will be held February 9 11, 2022.
 - Based on the reports and history, the potential of a significant rate increase may be discussed.
- The minimum wage was increased to \$12.80, effective January 1, 2022.
- Pool Update Conrad's Pool is scheduled to start in 1-2 weeks.
- Guard Shack (Coyote Wash) Update work is almost complete.

Council's Report

- Mayor McCollough attended the YRMC Administration Board Meeting. The focus was needed repairs at the hospital.
- Additional test kits are being delivered to Sunset Community Clinic and Dateland School.
