The current Expenditure Limitation is a state-imposed limitation set by a formula that incorporates the Census number. The current estimate is that in absence of the approval of this alternative expenditure limitation, the Town's total budget for all expenses, regardless of available revenue and reserves on hand, would be limited to approximately \$1.2 million below our present budget. There would be very little capacity to operate and sustain ourselves as an organization.

Town Manager Richard Marsh reviewed the budget and the reason to seek the Home Rule Alternate Expenditure Option as a Town. Multiple options were discussed to reach the States Expenditure Limitation that is currently imposed on the Town.
